

GREEN DOT® THANK GOODNESS IT'S WEDNESDAY (TGIW) SPIN & WIN GAME
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) U.S. STATES, THE DISTRICT OF COLUMBIA, AND PUERTO RICO WHO ARE AT LEAST EIGHTEEN (18) YEARS OLD AND THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE AT THE TIME OF ENTRY.

The Green Dot TGIW Spin & Win Game ("Promotion") is sponsored by Green Dot Corporation ("Sponsor"), P.O. Box 5100, Pasadena, CA 91117-0100 and is administered by Prize Logic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 ("Administrator").

- 1. PROMOTION PERIOD:** The Promotion begins on July 18, 2017 at 12:00:00 AM Pacific Time ("PT") and ends on October 23, 2017 at 11:59:59 PM PT ("Promotion Period"). The Promotion consists of fourteen (14) separate weekly entry periods (each, an "Entry Period") during each of which an entrant may accumulate up to six (6) Game Play Credits (as further described in Section 3 of these Official Rules), each followed by a "Game Date" when an entrant may play the Instant Win Game (as further described in Section 4 of these Official Rules), as set forth in the chart below (all times PT):

***NOTE** – All earned Game Plays for an Entry Period that are not completed on the applicable Game Date will not carry forward to subsequent Entry Periods. Sponsor's computer is the Promotion's official clock.

- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States, the District of Columbia, and Puerto Rico, who are at least eighteen (18) years old, and the age of majority in their jurisdiction of residence at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries and affiliates, distributors, and companies involved in the implementation and execution of the Promotion

("Promotion Entities") are not eligible to participate in the Promotion. Void where prohibited or restricted by law. By participating in this Promotion, an individual agrees to be bound by these official rules ("Official Rules") and that the Sponsor's decisions are be final and binding in all matters pertaining to the Promotion.

3. HOW TO ACCUMULATE GAME PLAY CREDITS: During each Entry Period, in order to participate, an eligible entrant must first accumulate Game Play Credits using the following three (3) methods:

A. Make a Qualifying Purchase On Your Account Card: During an Entry Period an eligible entrant who uses his/her Green Dot Reloadable Prepaid Visa® or Mastercard® card or Green Dot Cash Back Visa Debit Card (each, an "Account Card") to make a Qualifying Purchase will receive one (1) Game Play Credit. Green Dot Prepaid Cards acquired at a Financial Service Center ("Green Dot FSC Cards") are not valid Account Cards in this Promotion. For purposes of these Official Rules, a "Qualifying Purchase" is any purchase made on an individual's Account Card that is authorized to the respective Account Card by 11:59:59 PM PT on the End Date of the applicable Entry Period. **PLEASE NOTE:** For purposes of these Official Rules, a Qualifying Purchase is considered made on the date it is authorized to the respective Account Card, and not the date it is posted to the respective Account Card. There is no minimum value requirement for a Qualifying Purchase; the value of your Qualifying Purchase will not increase or decrease your chances of winning. **An entrant may accumulate one (1) Game Play Credit per Entry Period using this method of participation.**

B. Receive a Minimum \$200 Direct Deposit To Your Account Card: During an Entry Period, an eligible entrant who receives a Direct Deposit transaction totaling at least \$200 to his/her Account Card ("Direct Deposit") will receive five (5) Game Play Credits. In order to qualify as a Direct Deposit, the eligible Direct Deposit must be posted to the respective registered Account Card by 11:59:59 PM PT on the End Date of the applicable Entry Period. As long as the \$200 Direct Deposit value requirement is met, the value of the Direct Deposit above and beyond such value requirement will not increase or decrease your chances of winning. **An entrant may accumulate five (5) Game Play Credits per Entry Period using this method of participation.**

Note: Entrant must be a valid Account Cardholder with a successfully registered Account Card in order to enter via Purchase or Direct Deposit. By completing a Purchase or receiving a Direct Deposit at any point through the end of an Entry Period, the entrant hereby agrees to be bound by these Official Rules. Some entrants may have more than one Account Card. All eligible transactions from all Account Cards will be eligible to accumulate Game Play Credits, subject to the Game Play limits set forth in Section 4.

C. Alternative Method of Entry: To receive six (6) Game Play Credits for an Entry Period of the Promotion without being a Green Dot Account Cardholder and/or without making a Qualifying Purchase or \$200 Direct Deposit on an Account Card, visit <https://GreenDotTGIW.com/AMOE> and provide the required information, including your complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY), and click "submit" to receive six (6) Game Play Credits. On the Tuesday immediately following an Entry Period the Administrator will send an e-mail to the entrant with six (6) Game Play Credit codes (each, a "Code") and Game Play instructions. All Game Play Credit requests

must be submitted no later than the End Date of the applicable Entry Period in order to be eligible to participate on the Game Date for that Entry Period. Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of an entrant's privacy or spam filter settings which may divert any Promotion e-mail, including any Game Play Credit notification e-mail to a spam or junk folder.

GAME PLAY CREDIT LIMIT: An entrant may receive a maximum of six (6) total Game Play Credits per person, per Entry Period. If an entrant has more than one Account Card, he/she is still limited to six (6) Game Play Credits per person, regardless of the number of cards used to obtain Game Play Credits. If it is discovered or suspected, in Sponsor's sole discretion, that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or identities, or if an entrant attempts to receive more Game Play Credits than are set forth in these Official Rules, all of that entrant's Game Play Credits, in Sponsor's sole discretion, may be declared null and void and any Prize he/she might have been entitled to will be forfeited. Any entrant suspected of or found by Sponsor to be participating by automatic, programmed, script, bot, third-party or otherwise fraudulent method, in Sponsor's sole discretion, will be disqualified and all Game Play Credits earned by such methods will be voided and ineligible to win.

- 4. HOW TO PLAY THE INSTANT WIN GAME:** To play, on the respective Entry Period's Game Date, an eligible entrant must visit <https://GreenDotTGIW.com> (the "Website"), submit a valid e-mail address and, if a Green Dot Account Cardholder, the last 4 digits of his/her Account Card (if an entrant has more than one Account Card, all Game Play Credits accumulated in an Entry Period for all Account Cards associated with that entrant's e-mail address will be accessible, regardless of the card digits entered at the Website). The entrant must then enter the requested registration information, which may include, but is not limited to, complete first name (no initials), street address (no P.O. Boxes), city, state, ZIP Code, date of birth, and affirmation that he/she has read, understands, and agrees to these Official Rules. By participating in the Promotion, each entrant agrees to be bound by these Official Rules and to receive e-mail marketing messages from the Sponsor. An entrant may opt-out of receiving these e-mails at any time by clicking the "unsubscribe" link at the bottom of any such e-mail.

The entrant must then follow the on-screen instructions to receive one (1) Instant Win Game play ("Game Play"), including submitting a Code, if prompted, and follow the on-screen instructions to complete Game Play. Note: Account Cardholders will automatically have their Game Play Credits pre-loaded at the Website and will not need to enter any Code in order to complete a Game Play. After Game Play, the entrant will immediately receive notification on the Website screen as to whether or not he/she is a potential winner ("Instant Win Notification") and instructions on how to confirm eligibility and claim the prize. **Each entrant who receives an Instant Win Notification will be deemed a potential winner, pending confirmation and verification of the entrant's eligibility and compliance with these Official Rules, as determined by Sponsor in its sole discretion. An entrant is not a winner of any prize, even if the Website should so indicate, unless and until entrant's eligibility and the potential winning Game Play have been verified as determined by Sponsor in its sole discretion. Sponsor will not accept screenshots or other evidence of winning in lieu of its validation process. Upon completion of a Game Play, if an entrant has remaining Game Play Credits, he/she may follow the on-screen instructions to enter another Code (if applicable) and/or complete another Game Play.

Game Plays must be completed on the Game Date associated with the Entry Period in which the Game Play Credit was accumulated. Any accumulated Game Play Credits that are not completed during the associated Game Date will be void. An entrant may not “bank” Game Plays and Game Plays do not carry forward to subsequent Entry Periods.

GAME PLAY LIMIT: Regardless of how a Game Play Credit was obtained (or how many Account Cards an entrant has), an entrant is limited to up to six (6) total Game Plays on each Game Date. If it is discovered or suspected, in Sponsor’s sole discretion, that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or identities, or if an entrant enters or attempts to receive more Game Plays than are set forth in these Official Rules, all of that entrant’s Game Plays, in Sponsor’s sole discretion, may be declared null and void and any Prize he/she might have been entitled to will not be awarded to him/her. Any entrant suspected of or found by Sponsor to be participating by automatic, programmed, script, bot, third-party or otherwise fraudulent method, in Sponsor’s sole discretion, will be disqualified and all Game Plays made by such methods will be ineligible to win.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Grand Prizes (1 per Entry Period, 14 total): Each Grand Prize Winner will receive \$500 (the “Grand Prize”) either: (i) deposited into his/her Account Card (if he/she is a valid Account Cardholder when the Grand Prize is awarded); or (ii) in the form of a \$500 check made payable to the Grand Prize Winner (if he/she is not a valid Account Cardholder when the Grand Prize is awarded). Fourteen (14) Grand Prizes will be available in the Promotion – one (1) per Entry Period. The ARV of each Grand Prize is Five Hundred Dollars (\$500).

B. First Prizes (4 per Entry Period, 56 total): Each First Prize Winner will receive \$50 (the “First Prize”) either: (i) deposited into his/her Account Card (if he/she is a valid Account Cardholder when the First Prize is awarded) or (ii) in the form of a \$50 check made payable to the First Prize Winner (if he/she is not a valid Account Cardholder when the First Prize is awarded) . Fifty-six (56) First Prizes will be available in the Promotion – four (4) per Entry Period. The ARV of each First Prize is Fifty Dollars (\$50).

C. Second Prizes (15 per Entry Period, 210 total): Each second prize Winner will receive \$20 (“Second Prize”) either: (i) deposited into his/her Account Card (if he/she is a valid Account Cardholder when the Second Prize is awarded) or (ii) in the form of a \$20 check made payable to the Second Prize Winner (if he/she is not a valid Account Cardholder when the Second Prize is awarded). Two Hundred Ten (210) Second Prizes will be available in the Promotion – Fifteen (15) per Entry Period. The ARV of each Second Prize is Twenty Dollars (\$20).

D. Third Prizes (480 per Entry Period, 6,720 total): Each third prize Winner will receive \$5 (the “Third Prize”) either: (i) deposited into his/her Account Card (if he/she is a valid Account Cardholder when the Third Prize is awarded) or (ii) in the form of a \$5 check made payable to the third prize Winner (if he/she is not a valid Account Cardholder when the Third Prize is awarded). Six Thousand Seven Hundred Twenty (6,720) Third Prizes

will be available in the Promotion – Four Hundred Eighty (480) per Entry Period. The ARV of each Third Prize is Five Dollars (\$5).

E. Total ARV: The total ARV of all prizes available in each Entry Period is Three Thousand Four Hundred Dollars (\$3,400). The total ARV of all prizes available in the Promotion is Forty-Seven Thousand Six Hundred Dollars (\$47,600).

F. Odds of Winning: The odds of winning depend on when the entrant completes a Game Play. Prizes will be made available at random times on each Game Date. To be a potential Winner, an entrant's Game Play must have occurred at the exact randomly predetermined winning time for that specific prize, as determined by Administrator. If a Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Game Play to occur after that time will be deemed a Winner. Winners are responsible for all applicable federal, state and local taxes, if any. All prize details are at Sponsor's sole discretion. In no event will more prizes than are stated in these Official Rules be awarded. All prizes will be awarded provided there is a sufficient number of eligible Winners, and the prizes are claimed properly in accordance with these Official Rules. The Promotion Entities shall not be held responsible for any delays in awarding a prize for any reason. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded.

If, for any reason, more prize notifications are sent, or more claims are received, than the number specified herein, Sponsor reserves the right to award the intended number of prizes for the applicable prize level(s) for an Entry Period in a random drawing from among all prize claims received for the applicable prize level(s) for that Entry Period. Limit of one (1) prize per person/household per Entry Period. No prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure. All other costs and expenses not expressly set forth herein shall be solely the Winner's responsibility. The Promotion Entities shall not be held responsible for any delays in awarding a prize for any reason. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded.

6. HOW TO CLAIM A PRIZE: Potential winners who receive an Instant Win Notification are subject to verification of eligibility and compliance with these Official Rules. After receipt of the Instant Win Notification, potential winners will also be notified by email and may be required to complete and execute an Affidavit of Eligibility, Liability and Publicity Release (unless prohibited by law) and any other documents required by Administrator, which must be returned within seven (7) days of date appearing on prize notification. Further, if an entrant wins in multiple Entry Periods and his/her total prize winnings exceed \$600, he/she will be required to complete and execute an Affidavit of Eligibility, Liability and Publicity Release (unless prohibited by law), which must be returned within seven (7) days of date appearing on prize notification. If a notification e-mail or prize is returned as undeliverable, if a winner is found to be ineligible or not in compliance with these Official Rules, the prize may be forfeited, and in the Sponsor's sole discretion, the forfeited prize may be awarded to an alternate potential

In the event that a winner is an Account Cardholder and such winner's Account Card balance exceeds the maximum daily load or maximum balance due to addition of the prize, Sponsor will attempt to mail a check made payable to the winner to the mailing address associated with his/her Account Card. If, after a good-faith attempt, Sponsor is unable to provide or deliver a prize, the prize may not be awarded. Prizes are not transferable. ALL FEDERAL, STATE AND LOCAL TAXES IMPOSED ON THE ACCEPTANCE OF A PRIZE ARE SOLELY THE RESPONSIBILITY OF EACH WINNER. SPONSOR WILL ISSUE AN IRS-1099 TO ANY WINNER OF PRIZES TOTALING \$600 OR MORE. Each prize will only be provided to a verified winner.

The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any Website users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Promotion and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to any Promotion-related website(s). Released Parties are not responsible for any injury or damage, whether personal or property, to entrant's or to any person's computer related to or resulting from participating in the Promotion and/or accepting a prize. CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“AAA RULES”). THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING BUT NOT LIMITED TO ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORTING TO ANY FORM OF CLASS ACTION.
